in connection to your accession to the recruitment process, we are obliged to inform you that in the light of the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), **Przedsiębiorstwo Projektowo-Usługowe "NAVA" Sp. z o.o. based in Gdańsk**, at ul. The Company processes personal data in the form of name, date of birth, mailing address, e-mail address, telephone number, image captured on the photograph, and education and the course of previous employment under applicable labour law, in accordance with the Art. 6, para. 1, point c of the GDPR).

The transfer of your personal data is voluntary. However, a refusal to provide personal data will prevent the Company from carrying out the recruitment process.

The Company processes your personal data:

- over the duration of the recruitment process,
- throughout the process of verification in order to take legal and extrajudicial actions,
 in connection with possible claims for a contract of employment.

You also have the right to lodge a complaint to the President of the Office for Personal Data Protection, if you

consider that the processing of your personal data violates the Regulation (EU) 2016/679 of the European

Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing

of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data

Protection Regulation) as well as national provisions.
